2026 CONTRIBUTION AGREEMENT

We are delighted that you have chosen to become participants in The Greening Jersey Trust ("**Greening Jersey**"), in association with Jersey Finance (the "**Initiative**").

This Initiative is designed to support environmental enhancement, nature restoration and the rewilding of areas of our beautiful Island, and the aim is for Jersey's finance industry to collaborate and pool together resources to help transform and rewild sites across our island, where the benefits will be seen for years to come. Your contribution will be used to help to transform and rewild specific identified sites across the Island with our nominated charities. In our inaugural year Greening Jersey planted 860 trees and provided in excess of 600 hours of people power, working with The National Trust Jersey and Jersey Trees for Life. We plan to broaden the type of environmental projects and the charities we work with in 2026 and beyond, including working with Durrell Wildlife Conservation Trust on projects in 2026. The Initiative remains open to Jersey Finance member firms only.

The Initiative is run by a voluntary committee, and it is administered by Vistra Fund Services Limited in its capacity as trustee of The Greening Jersey Trust (the "**Recipient**"). Over time, opportunities for membership of the committee and also the role of Trustee are expected to rotate, thus providing as wide an opportunity for involvement in the Initiative as possible. During 2025, four new committee members were appointed.

What we want from you

In order to take part in the Initiative, Jersey Finance Members are requested to make an annual contribution of at least £1,000. However, to maximise and accelerate the impact of Greening Jersey we have suggested contribution levels for Jersey Finance Member firms in the table below, based upon headcount. The period for the 2026 annual contribution will run from 1 January 2026 to the 31 December 2026. The deadline to sign and return the agreement and pay the contribution amount is by 31 January 2026.

Suggested Contribution Scale (by Headcount):

Employees	Suggested Contribution
1–10	£1,000 (the minimum)
11–50	£1,500
51–100	£2,000
101–250	£3,000
251+	£5,000+

Basing the suggested contribution amount on employee numbers fairly reflects the volunteering opportunities available from Greening Jersey for all employees, and we hope that where smaller teams are able to contribute more, they will.

Greening Jersey is Complimentary to Corporate Memberships

We recognise that some participating firms are also corporate members of our nominated charities, The National Trust Jersey, Jersey Trees for Life and Durrell Wildlife Conservation Trust (the “**Charities**”). Greening Jersey was designed to provide different and complimentary benefits to what the corporate memberships offer, and we strongly recommend that firms continue their corporate memberships alongside Greening Jersey.

If a firm is a corporate member of the Charities, we are happy for such participants to **reduce the suggested contribution amount** by 10% (if a corporate member of one of the Charities), by 15% (if a corporate member of two of the Charities) and by 20% (if a corporate member of all three Charities), subject always to the contribution being no less than the minimum.

An invoice for the 2026 annual contribution can be provided if needed.

We will also require:

- a nominated email address that you consent for us to use to contact you regarding the Initiative; and
- confirmation that the funds will be sent from a bank account within Jersey, Guernsey, the Isle of Man, England, Wales or Scotland.

What you will get in return

In return for your contribution, as well as providing the much-needed funds to support our aim, the Initiative will also:

- give you the opportunity to join a number of collaborative volunteer sessions with the Initiative's Charities and other Participants to be held across the year;
- provide you with an official Greening Jersey Trust logo and certificate, which can be used to showcase sustainability credentials and commitment to environmental impact;
- social media tagging and references from the Greening Jersey LinkedIn page and related marketing activities; and
- an Annual Report from Greening Jersey on our activities, projects and details of how contributions have been used.
